SUBJECT: Reappointments to the Northeast Urban Renewal Board

MEETING DATE: August 5, 2013
MEETING TYPE: Action

RECOMMENDED MOTION: *Reappoint Daniel Doehring and Erik Nelson to the Northeast Urban Renewal Board.*

BACKGROUND: Three voting members on the Northeast Urban Renewal Board have terms which expired July 31, 2013. All four non-voting positions remain vacant. Two voting members have applied for another term.

This board is established under Section 7-15-4232 of the Montana Code Annotated. It consists of five members who serve staggered four-year terms after the initial appointment. The board shall consist of 5 voting members and not more than 4 non-voting members. The preferred composition of the voting members shall be:

- 2 business owners of businesses within the district;
- 2 residents from within the district;
- 1 member at-large.

Voting members must reside within city-limits or own property within the district. The board shall be responsible to:

- (1) develop plans which implement the vision of the district;
- (2) review on an ongoing basis the operation and processes of all public agencies to assure that such activities are supportive of the plan;
- (3) advocate and coordinate the complete and full implementation of the plan.

The NURB currently has three voting terms expiring and four ongoing nonvoting vacancies with two voting members reapplying.
